Your building is invited to participate in the Reach and Teach for Learning initiative with a four (4) to six (6) person team.

The **purpose** of *Reach and Teach for Learning* is **to improve learning results for students who are hard to reach and/or hard to teach.**

July 12 and 13, 2006 will serve as the core work session for a collaborative effort that will continue through June, 2007. Teams will develop plans to address professional learning and school improvement needs within their building. Two key national resources will join our July meeting: Cathy Hamilton, a Ruby Payne trainer, and Larry Gloeckler, from Bill Daggett's International Center for Leadership in Education.

Most of the work will be done within building teams. There will also be times when small cross-team groups will meet to address specific planning issues, i.e., each member from a team would select from among several breakouts, and then report back to the home team what was relevant for the building's planning.

There will be hard work, concrete results, meaningful learning, quality networking, and most importantly, enhanced support for improved student performance. We look forward to your involvement in this effort.
